Motion made by Frye, seconded by Cockerham. Motion carried.


11. Consider Conservation Work Precinct #2.

Motion made by Bradshaw, seconded by White. Motion carried.


12. Consider Any and All Matters Concerning the Parmer County Law Enforcement Center.
