Call to Order

1. Prayer

Commissioner Frye led the Court in prayer to begin the meeting.

2. Pledge of Allegiance to the American Flag and the Texas Flag

The Court pledged their allegiance to the flags of the United States of America and the State of Texas.

3. Read and approve Minutes from Previous Meeting

Motion by Bradshaw, seconded by White to approve the Minutes from the previous meeting.

Motion carried unanimously.

4. Consider Approval and Payment of Accounts Payable - Larry Johnston

Motion by White, seconded by Frye to approve the Payment of Bills/Accounts as presented by Mr. Johnston. Motion carried unanimously. See attached.

5. Consider Treasurer's Report – Altha Herington

Motion by Frye, seconded by White to approve the monthly Treasurer's report. Motion carried unanimously. See attached.

(A) Approve Calculated Payroll and Disbursement for all Parmer County

Employees and Elected Officials. See attached.

Motion by Cockerham, seconded by Bradshaw to approve the December 15th and December 31st Calculated Payroll and Disbursement for all County Employees and Elected Officials. Motion carried unanimously. See attached.

6. Consider budget Transfers and Amendments.

Mr. Johnston presented three budget amendments. See attached.

Motion by Frye, seconded by Cockerham to approve the budget amendments. Motion carried unanimously.

Motion by White, seconded by Bradshaw to approve the budget transfers Motion carried unanimously.

7. Agenda items 7 and 8 were combined into Consider Approval of Bonds for all newly elected and re-elected county officials.

The following bonds were presented: County Judge, Commissioners Precincts 1, 2 and 4, Justices of the Peace Precincts 1, 2 and 3, District Clerk, County Treasurer, County Clerk. The bond for the Justice of the Peace Precinct 2 was for one year and that will be corrected to four years.

9. Consider Engagement Letter with CRI for the Outside Audit

10. Consider Any and All Matters Concerning the Parmer County Law Enforcement Center

Sheriff Geries reported that there are 42 inmates currently. 19 are from other counties and are billing inmates.

He reported this year to date they have had 415 bookings and 11,297 bed days. This averages 28 inmates per day and 27.22 bed days per day.

He reported \$91,580.00 billed to date for housing other counties inmates.

He stated that he is fully staffed at the present and has 2 employees in training.

Prior to adjourning, Judge Ellis thanked Altha Herington, who is retiring for her years of service. He also thanked Larry Johnston for his years of service to the county as he is retiring at the end of the year.

He also thanked Commissioners Bradshaw and Cockerham for their service and willingness to act in the interest of Parmer County.

With no further business to come before the court, Commissioner White moved to adjourn. Commissioner Cockerham seconded and adjournment was called at 11:15 o'clock A.M.
