**DRIVER'S SAFETY COURSE (DSC): Code of Criminal Procedure: 45.0511**

1. Make your request in person or written request by CERTIFIED MAIL/RETURN RECEIPT REQUESTED, pay \$146.00 court cost only, cashiers' check/money order only, on or before appearance date on your citation. Provide proof of Valid Liability Insurance, a copy of Valid Texas Drivers' License, and Signed Affidavit. Out of State Driver's License will be accepted for Active duty Military and their Dependents to take Driver's Safety Course with proof of Active Duty Status
2. Have NOT completed or currently signed up to take a Driving Safety Course within the past 12 months (from date of offense) for ticket dismissal.
3. Disqualifications: NOT going more than 25 MPH or more over the posted speed limit or in a construction zone WITH workers present. Have had a Driving Safety Course in the last year. Hold a Commercial Driver's License.
4. If approved, you must inform the instructor that you are taking the course to have a ticket dismissed and to which court this ticket was assigned.
5. Sign the following sworn statement BEFORE a Notary Public or in the Judge's office. Request that one charge which is pending against you be dismissed by taking a Driving Safety Course.

**Due 90 days from request for DSC: Web Sites:** Texas approved courses can be found at [www5.esc13.net/drivers](http://www5.esc13.net/drivers). Present Court with signed Certificate of Completion. Provide a copy of your Driving Record (DR-1 form, request 3A) at [www.texasonline.com](http://www.texasonline.com) Military or dependents must request driving record from their home State. If you're 25 or younger and hold a Provisional License you must take a Department of Public Safety driving test and present results to the Court.

**Signed Affidavit:** I DO SOLEMNLY SWEAR that I have not completed a DSC within the 12 months prior to the date of citation nor am I in the process of completing a DSC for a citation in another Court. I understand that failure to comply and meet Court dates will result in my paying the fine or a warrant may be issued for my arrest.

1: I, \_\_\_\_\_ enter a plea of **GUILTY** and waive trial by Judge/Jury. (**Enclose Fine**). Guilty plea means that you are GUILTY as charged. The fine(s) and costs are the same as a plea of NO CONTEST.

2: I, \_\_\_\_\_ hereby enter a plea of **NOLO CONTENDERE/NO CONTEST** and waive trial by Judge/Jury. (**Enclose Fine**) No Contest plea means that you are not contesting the charges filed against you. If you plead NO CONTEST, a finding of guilty will be entered by the Court and the Court will assess fine(s) and costs.

3: I, \_\_\_\_\_ hereby enter a plea of **NOT GUILTY** and request the Court notify me of my docket date by mail or e-mail. Not Guilty means that you believe you are NOT GUILTY as charged. If you plead NOT GUILTY a docket date will be set. You are required to appear for that docket call. Failing to appear may result in you being charged with Failure to Appear (Section 38.11 Penal Code), additional fees, and a warrant may be issued for your arrest. It is not required that you be represented by an attorney, however, you may elect to do so. NOTICE OF YOUR COURT DATE WILL BE MAILED TO THE ADDRESS YOU HAVE LISTED or E-MAIL YOU PROVIDE TO THE COURT.

#### ALTERNATIVES TO PAYMENT OF FINES AND COSTS

1. Defendant may apply for a payment plan allowing the defendant to make payments toward the fine/costs in designated intervals. NOTE that if any amount is paid more than 30 days after the judgment assessing the fine/costs then a one-time fine fee must be assessed. All fines/costs are expected to be paid in full within 4 months. This may be extended to 6 months with the Judge's approval. Any payment plan exceeding 6 months for other reasons must be approved by the Judge and the defendant must state in writing why a longer period is necessary.
2. Disposition of the amount assessed by performing community service. There are options that meet the requirements of the law for community service, see Art. 45.049 of the Code of Criminal Procedure for full details. A defendant is entitled to a minimum of \$100 credit for every 8 hours of community service performed.
3. If performing community service imposes an undue hardship, a defendant who is indigent or who lacks sufficient resources to pay is entitled to a waiver of the fine/costs, in whole or in part. Understand a conviction of the charge will be filed against the defendant and will be on your record for 3 years.

**I understand that if I do not make timely payments, a capias warrant for my arrest may be issued with warrant fees attached. In addition, I further understand that other sanctions as authorized by law may be imposed to satisfy my fine/costs.**

The Law Provided that Failure to pay your fine or otherwise contact the Court by the APPEARANCE DATE, constitutes another offense and a charge of "Violate written promise to appear" can be filed against you resulting in your driver's license being reported to Austin to be flagged. Residents of another State, your Driver's License will be subject to suspension according to the non-resident violator's compact.
