MARKS AND BRANDS RENEWAL

Pursuant to Texas Agriculture code 144.044, all Marks, Brands and Tattoos currently registered with the Parmer County Clerk will expire on August 31, 2021. The renewal period for existing Marks/Brands/Tattoos will begin August 31, 2021 through February 28, 2022.

Any previously recorded Marks/Brands/Tattoos not re-registered by end of business on February 28, 2022 will be considered "void" and eligible for registration by anyone on a first come first served basis.

When you file a renewal, it is your responsibility to ensure the brand you are renewing is not currently in use by another person. Brands may be researched on line at: tscrabrands.com

Renewals should be made in person. If unable to do so, applications must have a notary public signature and stamp.

The recording fee for a mark is \$26 for **each location** on the animal.

Renewals may be filed with the Parmer County Clerk, Monday thru Thursday 8:30 AM-5 PM and Friday 8:30 AM-3 PM at the Courthouse in Farwell, 401 3rd Street.
