Call to Order

1. Prayer

Commissioner Frye led the Court in prayer to begin the meeting.

2. Pledge of Allegiance to the American Flag and the Texas Flag

3. Open Forum for Public Comments

4. Consider right of Way for El Paso Natural Gas Pipeline

Dustin Odell presented a renewal agreement for the agreement that was signed in 1959 for a 25 year term. He reported the renewal had been overlooked. It was also reported that the County Judge and County Attorney have reviewed the agreement.
