A RESOLUTION OF THE PARMER COUNTY COMMISSIONERS COURT OF PARMER COUNTY TEXAS REPEALING A RESOLUTION REGARDING TAXATION OF PERSONAL, NON-BUSINESS VEHICLES FOR PARMER COUNTY AND FM ROAD.

WHEREAS: THE PARMER COUNTY COMMISSIONERS COURT FOR PARMER COUNTY TEXAS, BELIEVE IT IS IN THE BEST INTEREST OF THE COUNTY AND ITS CITIZENS TO DISCONTINUE, TO THE EXTENT PERMITTED BY LAW, THE COUNTY PORTION OF *AD VALOREM* TAX(ES), PREVIOUSLY IMPOSED ON PERSONAL, NON-BUSINESS VEHICLES REGISTERED TO AN ADDRESS WITHIN THE COUNTY OF PARMER FOR COUNTY AND FARM TO MARKET ROAD; AND

WHEREAS: THE PARMER COUNTY COMISSIONERS COURT OF PARMER COUNTY TEXAS WISH TO EXEMPT THE CITIZENS OF PARMER COUNTY TEXAS FROM SUCH TAX(ES), TO THE EXTENT PERMEITTED BY LAW:

NOW, THEREFORE, BE IT RESOLVED BY THE PARMER COUNTY COMMISSONERS COURT OF PARMER COUNTY TEXAS THAT:

SECTION 1. Pursuant to the authority given this County Commissioners Court as the governing body of the Parmer County Texas, personal, non-business automobiles registered to an address within the county limits shall be exempted from *ad valorem* taxation by the County and Farm to Market Road, to the extent permitted by law.

SECTION 2. The tax-assessor-collector of Parmer County is hereby ordered and directed to cease, terminate, and otherwise stop the assessment, levy, and collection of the County portion *ad valorem* taxes on personal, non-business automobiles registered to an address within Parmer County Texas to the extent permitted by law.

SECTION 3. The passing of this Resolution does not relieve any person or entity from paying the County portion of the *ad valorem* taxes already assessed and levied prior to the effective date of this Resolution.

SECTION 4. This resolution shall be effective and in full force from and after 8-21-2003, or as otherwise permitted and prescribed by law.

SECTION 5. The passage of this Resolution shall repeal any wording of any existing resolution that conflicts with the wording of this Resolution.
