## NOTICE OF PUBLIC HEARING

The County Commissioners of Parmer County, Texas will hold a public hearing at 10:00 a.m., on Monday, November 13, 2023 at the Parmer County Courthouse, 401 3rd Street Farwell, Texas 79325 and via teleconference at Dial-In: 888-619-4629, Access Code: 35075223#. Among items to be discussed will be a proposal for the issuance by the Port Arthur Navigation District Industrial Development Corporation (the "Corporation") of revenue bonds or notes (the "Bonds") to loan the proceeds thereof to Route 86 Biogas, LLC (the "Company") and used (i) to finance or refinance the acquisition, construction, development, installation and improvement of solid waste facilities for the disposal of solid animal waste (manure), which is a waste by-product of heifer and dairy facilities operations located in Hale County, Texas and Parmer County, Texas (the "Project"); and (ii) to pay certain costs of issuance of the Bonds. The Project will consist of structures and equipment designed and intended solely to aid in the collection and disposal of waste cow manure and collection of biogas. Upon completion, the Project will consist of an anaerobic digester that will process solid animal waste cow manure into a fertilizer supplement and capture renewable gas that will be further processed and injected into the natural gas pipeline. As part of the anaerobic process, gas is collected, processed (i.e. cleaned and scrubbed) and pumped into a nearby natural gas pipeline.

A portion of the Project will be located at heifer and dairy facilities in Hale County, Texas ("Hale County") and the remaining portion of the Project will be located at heifer and dairy facilities in Parmer County, Texas ("Parmer County"). The approximate location of the portion of the Project located in Hale County is located at 1505 County Road Y Plainview, Texas, Hale County, Texas 79072 (the "Hale County Facilities"). The approximate location of the portion of the Project located in Parmer County is located at 2450 Highway 86 Friona, Texas, Parmer County, Texas 79035 (the "Parmer County Facilities"). The Project will be owned by the Company. The maximum aggregate principal amount of the proposed Bonds to be issued is anticipated not to exceed \$16,000,000. The maximum aggregate principal amount of the Bonds proposed to be issued to finance the Hale County Facilities is anticipated not to exceed \$6,500,000. The maximum aggregate principal amount of the proposed Bonds to be issued to finance the Parmer County Facilities is anticipated not to exceed \$9,180,000. The remaining proceeds will be used to finance allowable costs of issuance.

All interested parties are invited to submit written comments to the Board at the address below prior to the time set for the public hearing, to call into the public hearing via teleconference or to attend the public hearing and express any comments they may have regarding the Project of the proposed Bonds. This notice is published and the above-described hearing is to be held in satisfaction of the requirements of section 147(f) of the Internal Revenue Code of 1986, as amended, regarding the public approval prerequisite to the exemption from federal income taxation of interest on the Bonds.
